**1. CALL TO ORDER**

The meeting was called to order by Beth Murena, President, at 10:30 am. Other members present were Jeannetta Cimo, Marilyn Hinman, Terri Mullin, Helga Mycroft, Nancy Schatz, Rosanne Scholey, Diana Van Riel, and Carol Whitton.

**2. BOARD OF DIRECTORS' REPORTS**

- a. **President.** Beth stated the meeting was being held to specifically discuss Programs and one other item. With that said, she turned the meeting over to Jeannetta Cimo, co-1<sup>st</sup> Vice President (Programs).
- b. **1<sup>st</sup> Vice President (Programs).** Jeannetta Cimo read the following statement:

*Before Covid we were in person only, if you wanted to take a class you went where the class was. A teacher would teach the same design to several chapters earning money in each of those places to those limited audiences. Now with zoom you aren't restricted to one chapters members as your audience your class is now released onto Facebook, pages, groups, email lists etc., exposing it to many or all of your potential students/customers. Designer/teachers are not limited to traveling around picking up teaching jobs in person they have the opportunity to go to zoom to teach, advertise on/in Facebook/groups and can make a pretty decent amount of money for their time/talent. For our chapter that offers a flat fee we may be selling our designer/teachers short inn compensation because they really don't need us to be able to teach, currently we need them to be able to offer programs to our members. For chapters that offer teachers \$15 per student they benefit for the amount of students in the class so therefore advertising on Facebook in groups and email list would benefit the teacher as well as the chapter but those class rates are somewhat higher. Example \$15x27 students is \$705 however the classes are usually much longer. Another consideration, the design has been released out into Facebook, the people interested in it take the class, that design may have some potential to sell patterns to people that don't do Zoom or to a different audience but most of the income from it has been passed to the chapter. However, there could be a benefit to a lesser known artist/designer by exposing them to some students that designer would have not been in contact with prior, possibly leading to additional sales of other patterns. Also, if it's a design that was seasonal they could design other pieces which they could then advertise and possibly pick up some of these students for classes for themselves in the future. We as a chapter can advertise the designer, a website, Facebook page etc. which could also benefit the designer. It's not all bad, a lesser known designer may find these types of incentives, free advertising having the benefit of practice if they are new to teaching, having potential after class sales and things like that as a good thing?*

Now I'm just going to mention this because I reached out to a couple (of) popular, big brush type designers to try to get some answers or some information to see what things are gonna look like with teachers that don't design, that are trying to teach other designers patterns. I haven't had much luck yet only one response and that was from Chris Haughey. She responded to my email and said with permission a teacher can teach her designs for a chapter via zoom for up to 25 people only. I didn't get any other specifics but at least I know the restrictions as far as how many students whether or not we really want to exclude members or nonmembers because we have over 25 interested that's some thing that I guess we will decide if we run out of better options. Having our teachers look for designers maybe less known or have fewer restrictions of course would be best case scenario, still awaiting more feedback.

So anyway that's why we are here today. When the subject of teaching zoom was brought up we didn't know that we were going to have complications with designers on whether or not you could teach their designs in this format so Rosanne and I have talked a bit about the possibilities of problems or issues coming up and how to address them on the front side. So since this subject includes money we needed to bring it to the board and have a vote so that when we design the teacher contract and talk to the teachers about our programs for 2021 we will have a format that we can utilize to get our teachers booked for next year.

So here are some numbers! When we met in person in the church sometimes we had 15, sometimes 25, give or take either way, so we came up with an average of attendance of 20. So since we started zoom the first class was members only just to feel it out and see how it would go, it went well. The next three, we have advertised outside of our chapter have had much higher numbers of attendees 30-50, our current class is about 50. Our programs used to be under performing financially and now have become over performing as far as income to the Chapter. So going into 2021 we discussed some scenarios that would possibly come up.

**Scenario one**

We have a teacher that is also the designer. Teacher provides prep and pattern in E form to the program chairs to distribute. Teacher receives the teachers fee of \$125 for the first 20 students. For all students over 20, which are mostly nonmembers anyway and have paid \$5 more to attend the class, teacher would receive \$5 per student.

**Scenario two**

We have a teacher that is teaching a pattern from a designer that requests no compensation. Teacher provides prep and pattern in E form to the program chairs to distribute. Teacher receives the teacher fee of \$125. The chapter pays the designer a fee of \$5 per student over the first 20 for compensation which hopefully would be looked upon favorably and could result in that designer allowing us to use their designs in the future.

We have a teacher with a project from a designer that requests to buy a pattern for each student. Teacher receives the teacher fee of \$125. Students receive a \$5 discount when they take the class. The student then must go and purchase the pattern directly from the designers website, etc.

Kathy has done this design on a standard clip board as well as a large and small surface. You can adapt it to whatever surface or similar sized item in your stash.
