BOARD OF DIRECTORS' REPORTS

She said they are working on projects for next year. The January 2020 project will be a "Design Your Own" Valentine lid for the glass candy dish we've done in the past. Three samples were shared. Each participant will receive one lid and one dish (if they need one).

2nd Vice President (Membership). Not present. Janet Mitchell sent notification that she would not be able to attend the meeting as she is out of the state.

Secretary. Nancy Schatz was unable to attend as she has moved to Lake Havasu. In her absence, Rosanne Scholey read the October 1, 2019 minutes. There was a correction to strike ..."Becky and Jeannetta just asked everyone to get baking for Granny's Pantry. pm;" **A motion was made by Marilyn Hinman and seconded by Diana Van Riel to approve the minutes as corrected; motion passed.**

Treasurer. Marilyn Hinman presented the October 2019 Treasurer's report. The Beginning Balance for October was \$8,116.89. Income for the month totaled \$33,378.08. Expenses were \$29,259.95. This left us with an ending balance of \$12,235.02. **A motion was made by Rosanne Scholey and seconded by Diana Van Riel to approve the report as presented; motion passed.**

Ways and Means. Diana Van Riel reported that the October Chapter meeting has Debbie Ragains and Donna Nelson doing the raffle prizes with Janet Mitchell as the Featured Artist.

COMMITTEE REPORTS

Charities. Not present.

Christmas Party. Not present. Heidi Allison sent a written report to Carol Whitton since she is currently traveling out of state. The event is sold out with 42 participants (if Barbara Underwood brings her two friends). They are within their budget. They are currently prepping surfaces as she and Janet are traveling across country. The menu is planned (baked potato bar) and will be delicious. Decorations are in progress. The deposit for the teacher was mailed out months ago. Plans are to take the teacher out to dinner on Saturday, November 23rd, and everyone is welcome to come along.

Holiday Boutique. Becky Bolding reported that the Holiday Boutique went very well. We exceeded our proceeds from the previous year! There were 63 tables of which 22 of the sellers were DQT members and 32 were outside vendors. Some concerns were expressed about the motives of at least one person attending the boutique. It was suggested that we look into the possibility of hiring a "Security Guard" for next year to be stationed outside. We do have the Citizens Patrol team who provide security inside. Becky also thanked everyone who baked for Granny's Pantry. She also announced the following changes for next year: 1) they will charge vendors \$15 for small racks and \$25 for large racks in addition to their table charge, 2) table prices will increase for nonmembers in 2020 (\$50) and will remain the same for DQT members (\$35), 3) they will hire the church's cleaning crew next year, and 4) if a vendor requests that their check and tags be mailed, there will be a \$7.50 priority mail charge to them which will be taken out of their proceeds.

Holiday Raffle. Marilyn Hinman provided a written report on the Holiday Raffle. Ticket sales totaled \$1,212. Expenses were \$243.71 with left us with a profit of \$968.29. Marilyn said she was not able to continue as the chairman of this committee for 2020. Anyone willing to chair the committee should let Beth Murena know.

Hospitality. Annette Lamarre stated she is covered for the December meeting with three people.

Nominations. Carol Whitton mentioned that Cathy Duke-Immel had to withdraw from being the 2020 Treasurer due to health concerns. Marilyn Hinman has agreed to continue in the position of Treasurer and Janet Mitchell agreed to continue as the 2nd Vice President – Membership. This change was presented at the October 22, 2019 Chapter meeting, voted on, and approved.

October Painting Month. Sue Clark reported there was lots of participation at the demonstration table during the Holiday Boutique. She recommended that we have fewer people scheduled to demonstrate at the same time for next year.

Quail Eggs. Not present.

Special Raffles. No report.

Summer Seminar. Rosanne Scholey reported they've received a few submissions from Chris Haughey. She feels what Chris has submitted thus far is too easy for a full day seminar. Once they have adequate submissions, they will be presented to the Board to make a final decision.

OLD BUSINESS

There was no Old Business to discuss.

NEW BUSINESS

Granny's Pantry: Diana Van Riel reported that prices will be raised for next year. There will no longer be 25¢ items. They will also devise guidelines for pricing so that similar items are priced the same. Kudos were given to Shirley Golding who brought 10 boxes of food items. It was suggested that larger items be put on a plate, in a box, or a tin. Becky Bolding also mentioned that we need to use quality products when baking (i.e. no out of date nuts). We also need to make certain that when baking that we use clean surfaces and utensils.

Evaluation of Quail Eggs Program: A discussion took place regarding the value of the Quail Eggs Program. The program was developed to encourage members to volunteer for a variety of tasks necessary to keep our Chapter running smoothly. It seems as though it continues to be the same members who volunteer. **It was moved by Rosanne Scholey and seconded by Beth Murena to eliminate the Quail Eggs Program for the 2020 year. The motion carried.** It was also discussed that we need to approach each member individually about donating a prize (raffle basket) or money to Ways and Means. We will give members an opportunity to support the Chapter in this way at our Christmas Party for the 2020 year. Since we've eliminated the Quail Eggs Program for 2020, we will approach Donna Nelson about assisting Diana Van Riel throughout the year with Ways and Means.

"Member in Good Standing" Discussion: **A motion was made by Rosanne Scholey and seconded by Marilyn Hinman that we add the following statement to our Standing Rules. "A Member in Good Standing will be defined as one who has paid their National and Chapter dues by January 1st and has made a minimum donation (raffle prize or cash) of a value of \$25 or more to Ways and Means."** After a lengthy discussion, **the motion was defeated.**

Checks Issued to General Meeting Teachers: Sue Clark expressed a concern about the compensation teachers for Chapter meetings receive. Specifically, she would like to receive clarification for what she is being paid. It was agreed that this will be provided to each teacher when they are given their check.

Special Raffles Money Discussion: Carol Whitton stated this agenda item was placed for discussion for two reasons: 1) Janet Mitchell requested the Board consider having the Special Raffles money raised at the Christmas Party go back into the Chapter's General Fund and 2) after researching minutes from April 2017 to the present, there has never been action taken to state that the Board decides how Special Raffles money should be allocated after each event (Community Service Project, Summer Seminar (2 days), and Christmas Party). **It was moved by Beth Murena and seconded by Rosanne Scholey that the Special Raffles money from the 2020 Christmas Party go back into DQT's General Fund. The motion carried.** After further discussion, **it was then moved by Beth Murena and seconded by Rosanne Scholey that the Board will determine how the Special Raffles money will be allocated for each event on a case by case basis. The motion carried.**

FUTURE AGENDA ITEMS

2020 Project Cost: This item will be discussed and decided upon at the January 2020 Board Meeting.

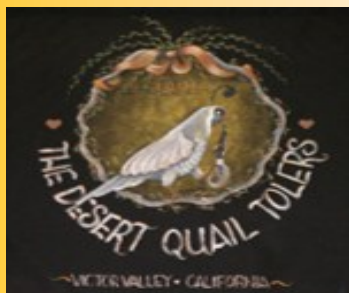
NEXT MEETING
